Advocate General for the State/respondent No.1.</p> <p>Heard.</p> <p>The petitioner, who is the President of Janpad Panchayat, Balrampur, District-Surguja(CG), has prayed for cancellation of the entire selection process of Panchayat Shiksha Karmi Grade-III of the said Janpad Panchayat and also for a direction to make fresh selection according to the prescribed rules.</p> <p>Learned counsel for the petitioner submits that though he is the head of the Institution but, the selection committee is not obeying his instructions and the selection process is going on against the rules. He also submits that he had made a representation before the concerned Collector vide Annexure P-5 on 29.4.2006 but, the Collector is also not taking any interest and the irregularities in the selection are still continuing. He submits that the interview has already taken place but the selection list has not been published so far.</p> <p>In view of the above, in the opinion of this Court, the petition appears to be pre-mature. At this stage, I am not inclined to interfere in this petition. The petition is dismissed.
