. By consent of the parties, the following order is passed.

. The decree passed against defendant no. 1 in Suit No. 3884 of 2001 is st aside. By consent of the parties, the defendant no. 1 to deposit a sum of Rs. 2,50,000/- in respect of the claim covered by all the aforesaid suits including the aforesaid

three summonses for judgments. If the said amount is deposited the defendant no. 1 will get unconditional leave to defend in all the four suits. If the amount is not deposited, the plaintiffs will be entitled to decree as against defendant no. 1 in all the four suits. If the amount is deposited, written statement to be taken on record. This deposit is over and above the amount already deposited by the defendant nos 2 and 3 in each of the aforesaid suits. The amount if so deposited, the Prothonotary and Senior Master is directed to deposit the same in a fixed deposit with any nationalised bank initially for a period of one year and renew the same from time to time till further orders from this Court. Summons for judgment disposed of accordingly.

2. Suit transferred to the list of Commercial Causes. Written Statement or points of defence to be filed four weeks from the date of deposit. Affidavits list of documents to be filed within four weeks thereafter. Inspection within four weeks thereafter. Suit to be on Board of the learned Judge taking Commercial Causes.
