JUDGMENT

P.N. Ravindran, J.

A.S.No.102 of 2001 arises from the decree and judgment passed by the Court of the Subordinate Judge of Thrissur in O.S.No.589 of 1996. The appeal was originally filed in the District Court, Thrissur where it was numbered as A.S.No.417 of 2000. Upon receipt of summons the first respondent in the appeal filed a memorandum of cross objections. Later, A.S.No.417 of 2000 was withdrawn from District Court, Thrissur to this court and numbered as A.S.No.102 of 2001. A.S.No.102 of 2001 was dismissed as withdrawn pursuant to a settlement entered into between the parties. The cross objections was however not disposed of.

2. When the cross objections came up for consideration today, learned counsel appearing for the cross objector/first respondent in the appeal submitted that the cross objector passed way on 9.12.2001. Learned counsel also submitted that in view of the fact that the dispute between the parties was settled out of court and the appeal itself was dismissed as withdrawn, the cross appeal may be closed as abated. In

the light of the said submission the cross appeal is closed as abated.
