O R D E R

The petitioner is before this Court, under Section 438 Cr.P.C., as he apprehends arrest in crime No.220/2006 of Changaramkulam Police Station, for the offence punishable under Sections 403, 406 and 498A IPC.

2. Considering the materials that are placed before me and the submissions made by either side, I direct the petitioner to surrender before the Investigating Officer in crime No.220/2006 of Changaramkulam Police Station, on 7.8.2006 between 10.00 a.m and 11.00 a.m. The Investigating Officer shall interrogate the petitioner and complete the investigation, and in the event of his arrest, he be released on bail, on he executing a bond for Rs.25,000/-, with two solvent sureties, each for the like sum, to the satisfaction of the Investigating Officer arresting him.

3. The petitioner shall submit his passport for scrutiny by the investigating Officer, and thereafter, the same shall be returned to the petitioner, if the investigation so far as the use of the passport is complete, or in any case within thirty days from the date of its production, before the investigating officer.

4. I make it clear that the petitioner is not prevented from going abroad for his work, but he shall be present before the Court, if a final report is filed against him, to answer the charges that may be levelled against him.

The application is disposed of as above.
