ORDER

The petitioners accused in crime are Medical Police No.282/2006 of College Station. Thiruvananthapuram. The offence alleged against them, at the instance of the third respondent, Sunitha, the wife of the first accused, is under Section 498A IPC read with Section 34 IPC.

- 2. I heard both sides. The learned Public Prosecutor brought to my notice that the defacto complainant, Sunitha, and her father had sustained injuries at the hands of the first petitioner, the husband of Sunitha. However, the learned counsel submitted that the occurrence took place in the year 2002, while the first petitioner was undergoing house surgency in the medical college hospital, where his mother-in-law, the mother of Sunitha, was working as Sweeper.
 - 3. After hearing both sides and considering the

facts that are placed before me, I direct the petitioners to surrender before the Additional Chief Judicial Magistrate Court, Thiruvananthapuram, on 7.8.2006 at 11.00 a.m. The learned Magistrate shall allow the petitioners to be on bail, imposing such conditions, as are deemed necessary.
