#### ORDER

The petitioners are accused Nos. 1 and 3 to 6 in crime No.635/2006 of Perinthalmanna Police Station, for the offence punishable under Section 395 IPC. The first accused was arrested on 16.9.2006 and accused 3 to 6 were arrested on 17.9.2006. They remain in judicial custody. Hence this application.

- 2. I heard the arguments advanced by both sides. Without entering into any discussion on the merit of the matter, I grant bail and release the petitioners from jail, subject to the following conditions:-
  - (a). Each petitioner shall execute a bond for Rs.25,000/-, with two solvent sureties, each for the like sum, to the satisfaction of the Judicial Magistrate of First Class-I, Perinthalmanna.

- (b). The petitioners shall report before the Investigating Officer, once in a week on every Saturday, between 10.00 a.m and 11.00 a.m., for a period of three months, starting from 4.11.2006, and thereafter, on the first working day of every month, between the same timings, till the final report is filed.
- (c). The petitioners shall not leave the State of Kerala, until the completion of the trial and final disposal of the case.

The application is allowed as above.
