#### ORDER

The 4<sup>th</sup> accused is the applicant and he is alleged to have committed offence along with others under Sections 143, 147, 148, 452, 341, 323, 324, 294(b), 427 and 395 read with Section 149 of I.P.C. and Section 27 of the Arms Act. He is in judicial custody from 3.12.2006 onwards. The investigation is in progress. It is submitted that some of the accused are yet to be arrested. There is no point in indefinitely detaining him and therefore, the petition is allowed and the petitioner will be released on bail on stringent conditions.

- (i) He shall execute a bond for Rs.25,000/- with two solvent sureties each for the like amount to the satisfaction of the Munsiff-Magistrate Court, Paravur.
- (ii) The petitioner shall not enter the limits of Parippally Police Station for a period of one month from today, except for the purpose of reporting before the Investigating Officer.
- (iii) He shall report before the Investigating Officer on every
