COMMON ORDER

(Common Order of the Court was made by P.SATHASIVAM, J., )

The petitioners have approached this Court to issue a Writ of Mandamus, directing the  $1^{\rm st}$  respondent-Assistant Director, District Employment Office, Salem, to sponsor the names of the petitioners to the Salem District Central Cooperative Bank ( $2^{\rm nd}$  respondent in W.P.No.5878 of 2001 and  $3^{\rm rd}$  respondent in W.P.Nos.3219 and 3583 of

2001) to permit them to participate in the interview for the posts of Assistants.

- 2. It is not in dispute that in pursuance of the interim direction of this Court, as on date nothing survives for adjudication. In those circumstances, though the petitioners have filed WPMP.Nos.9365 and 9366 of 2005 and 18717 of 2006 seeking amendment of the reliefs sought for, we are not inclined to accept the same. However, if they have any grievance, they are free to file a fresh writ petition highlighting all the details.
- 3. With the above observation, all the writ petitions are dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
