ORDER:

Challenging the action of the respondents in not granting pattadar pass books and NOC in favour of the petitioner in respect of land admeasuring Ac.5.00 in survey No.1024/2(Part) situated at Malkaram Village, Shamirpet Mandal, Ranga Reddy District, petitioner filed this writ petition.

Heard the learned counsel appearing for the petitioner and the learned Government Pleader for the respondents and perused the material on record.

It is the case of the petitioner that he being the ex-service man and landless poor, on his application, an extent of Ac.5.00 cents of land in Survey No. 1024/2 situated at Malkaram village, Shamirpet Mandal, Ranga Reddy District was allotted

to him by the Jawaharnagar Cooperative Land Colonization Society vide general body resolution dated 07-04-1979 and thereby he has paid a sum of Rs. 125/- on 03-06-1979 in favour of the said Jawaharnagar Cooperative Land Colonization Society. But the said land has not been mutated in his name and therefore, he has filed a representation before the Collector, Ranga Reddy District on 08-08-2005 marking a copy of the same to the Mandal Revenue Officer, Shamirpet Mandal, Ranga Reddy District. Hence this writ petition seeking to declare the inaction of the respondents in not mutating his name in respect of the said land in revenue records by considering his representation.

Learned Government Pleader appearing for the respondents submits that the said land is government land and the petitioner is not at all in possession of the said land and the entire land in an extent of 61 acres situated in Survey No.1025/2 of Jawaharnagar was allotted to the HUDA and possession was also handed over in favour of HUDA in the year 2000 by conducting punchanama and the said land is covered by Kancha, Hillock & Vacant and as per the records, the said land was not allotted to the petitioner by the said Jawaharnagar Cooperative Land Colonization Society and recently, the said land was allotted in favour of third parties.

In the absence of any admissible record of allotment of the said land by appropriate proceedings, it may not be just and proper to issue any direction directing the respondents to issue patta certificate and NOC in favour of the petitioner.

Writ petition is accordingly dismissed. However, petitioner is at liberty to approach the authorities concerned by producing relevant material for the purpose in question. No order as to costs.
