- 2. The petitioners have filed this writ petition for the following reliefs:
 - "(i) Issue a writ, order or direction in the nature of certiorari quashing the orders dated orders dated 8.02.2006, 8.01.2003, 27.01.2006 and 14.02.2006 contained in Annexure No. 1, 2, 3 & 4 respectively.
 - (ii) Issue a writ, order or direction in the nature of mandamus directing the Respondent No. 3 to register the Society by the name of "Libberhedi Sahkari Ganna Vikas Samiti Ltd. Libberhedi" under the provisions of the Uttaranchal Co-operative Societies Act.
 - (iii) Mould or grant any relief which this Hon'ble Court deems fit and proper in the facts and circumstances of the case."
- 3. The petitioners' main grievance is against the rejection of their application vide order dated 08.02.2006 (Annexure No. 1).

- 4. During the course of hearing, it transpired that the petitioners have a statutory alternative remedy of filing an appeal against the impugned order dated 08.02.2006.
- 5. In our opinion, it would be appropriate for the petitioners to first exhaust the statutory remedy available to them against the impugned order dated 08.02.2006 (Annexure No. 1).
- 6. With the above observation, the writ petition stands disposed of.
- 7. With the above order, CLMA No. 6403 of 2006 also stands disposed of.
