By the present writ petition, the petitioners have prayed for a writ of mandamus directing the respondents to appoint the petitioners on the post of Assistant Teacher in L.T. Grade on Ad-hoc basis in compliance of the Government Order dated 7-10-2005. At the time of hearing the petitioners have confined their prayer for compliance of G.O. dated 7-10-2005 only.

Accordingly to the petitioner they have passed M.A. B.Ed. They have applied for the post of Shiksha Bandhu against the vacant post of Assistant Teacher in the L.T. Grade. They have submitted that they continuously worked as Shiksha Bandu in Government Inter colleges in Kumaun and Garhwal Region in three continuous academic sessions. According to them they are fully qualified for being appointed in terms of G.O. dated 7-10-2005.

view of above, liberty is given to the petitioners to prefer а representation the appropriate authority of the respondents within 15 days after obtaining the certified copy of this order, who shall decide the dame within four weeks thereafter.

Accordingly, the writ petition is disposed of. No order as to costs.
