# ORDER

The petitioner is the accused in Excise Crime No.43/2005 of Thottilpalam Police Station.

- 2. The offence alleged against the petitioner is under Section 8(2) of the Abkari Act.
- The prosecution case is that on 18.3.2005,
  petitioner was found in possession of two bottles containing 500 ml.
  each of illicit arrack.
- 4. The petitioner was arrested on 15.8.2007. He was produced before the Judicial First Class Magistrate Court, Nadapuram, and he was remanded to judicial custody.
- 5. The incident took place on 18.3.2005, and the case was pending as L.P.No.152/2006. The petitioner was absconding. However, taking into account the fact that the quantity of arrack involved is only one litre, I am inclined to take a lenient view.
