#### ORDER

In this Petition filed under Sec. 439 Cr.P.C. the petitioner who is the accused in Crime No.744/2007 of Chalakudy Police Station for offences punishable under Sec.307 I.P.C., seeks his enlargement on bail.

- 2. I have heard the learned counsel for the petitioner and the learned Public Prosecutor.
- 3. Having regard to the nature of the offences, the duration of judicial custody of the petitioner, the present stage of investigation and the other circumstances of the case etc., I am inclined to grant bail to the petitioner. Accordingly, the petitioner is directed to be released on bail on his executing a bond for Rs.10,000/- (Rupees ten thousand only) with two solvent sureties each for the like amount to the satisfaction of the J.F.C.M, Chalakudy, and subject to the following conditions:
  - The petitioner shall report before the Investigating Officer between 9 a.m. and 11 a.m. on all Wednesdays.
