Petitioner is aggrieved by Ext.P3. There is also a grievance that no licence is granted to the petitioner for want of no-objection certificate from the landlord. No objection certificate from the landlord is not necessary for granting licence, in case the applicant is otherwise eligible, is now settled by the decision of this Court in **Marimuthu v. Director General of Police** (1999 (3) KLT 662). There will be a direction to the first respondent to take appropriate action on the application filed by the petitioner, in the light of the decision referred to above, within three months from the date of production of a copy of the judgment. The interim order dated 27.10.2004 will continue till such time.

The writ petition is disposed of as above.
