Writ Petition under Article 226 of the Constitution of India S.B Hon'ble Shri Dhirendra Mishra, J. 30-09-2008

Grievance of the petitioner is that he was working under Janpad Panchayat, Bilaigarh, Distt. Raipur as daily wage employee vide order of Annexure P/1 dated 10.4.1997. Subsequently, the work of maintenance of hand pump and tube well, provided by the Janpad Panchayat in various villages, was handed over to the Public Health Engineering Department in the year 1999. Accordingly, services of the *petitioner were also taken over by the Public Health Engineering Deptt. of the State Govt. and since then, he was working under the Public

Health Engineering Deptt. till 31st December, 2007. However, his services have been discontinued from 01st January, 2008 without any formal order in this regard. In the meanwhile, the State Govt. vide Circular dated 5th March 2008 has decided to regularize the services of the daily wage ad hoc employees, who are appointed between 1.1.1989 and 31.12.1997

Learned counsel for the petitioner submits that he is not pressing this petition at this stage. However, he prays for liberty to make a detailed representation before the competent authority of the respondents to apply for reappointment and regularization in view of Circular dated 5th March, 2008, which may be decided on its own merits, in accordance with law.

Shri Ajay Dwivdi, learned Dy GA for the State has no objection if the petition is disposed of with the aforesaid liberty.

In view of above submissions of the parties, the instant petition is disposed of with liberty to the petitioner to file a detailed representation for reappointment and regularization before the concerned competent authority of the State Govt. On such representation being filed, the same shall be decided on its own merits in accordance with law, within a period of three months from the date of receipt of such representation.
