ORALORDER (Passed on 31.3.2008)

Per Dhirendra Mishra, J:

- 1. Heard.
- 2. The common question involved in these petitions are that the petitioners, who belong to scheduled caste, scheduled tribe and other backward categories and residents of other States, are pursuing their studies in B.Ed. course in different educational colleges of the State. They have been admitted in the said course after successfully participated in the common entrance examination conducted by the State Council for Education Research and Training (for short 'SCERT') through Chhattisgarh Professional Examination Board and they were allowed relaxation of 5% in the minimum marks required in the prequalification examination. However, the respondent-Guru Ghasidas University, Bilaspur (for short 'University') has refused to issue admission cards to the petitioners on the ground that their admission to the above course by allowing relaxation of 5% is illegal, as the petitioners are residents of other State and therefore, they are not entitled for relaxation on the ground that they belong to scheduled caste, scheduled tribe and other backwards classes categories, as the same is available only to the candidates of the above categories who are residents of the State of Chhattisgarh.





- 3. Learned counsel for the petitioners submit that similar objection of Pt. Ravi Shankar Shukla University, Raipur in Writ Petition [c] No.7232/07 between Soni Rakhi Bek and others Vs. State of C.G. & others and other connected petitions has been decided by this Court vide order dated 28.3.2008 and these petitions may also be disposed in terms of the above order. This fact has not been disputed by learned counsel for the respondents.
- 4. In view of the order dated 28.3.2008 passed in Writ Petition [c] No.7232/07 between Soni Rakhi Bek and others Vs. State of C.G. and others, these writ petitions are also allowed and it is directed that;
 - i. respondent-Guru Ghasidas University, Bilaspur shall not give effect to their decision communicated through their memo dated 1.3.2008 issued to the Principals of affiliated educational colleges regarding withholding of issuance of admission cards so far as it relates to the petitioners herein.
 - ii. It is further directed that if the petitioners are otherwise eligible to appear in the final examination, they shall be issued admission card for appearing in the final examination of B.Ed. course for the year 2007-08.
- 5. No order as costs.
