Accordingly, we issue an interim mandamus to the State of Himachal Pradesh to consider the case of the petitioner within seven days at any of the stations of his choice, except Mandi.

List this case on 8th January, 2009. If the representation is not disposed of by a speaking order, the Principal Secretary concerned shall appear in person before this Court. Copy **dasti**, if possible. The Advocate General shall inform this order to the authorities concerned.
