**JUDGMENT**

**K. M. JOSEPH, J:**

Complaint of the petitioner in the Contempt Petition is that the 3rd applicant in the IA has violated Annexure E Order of this Court. Today, when the matter came up, Shri K. Jaju Babu, learned counsel for the petitioner would submit that in the light of the stand taken in paragraph 7 of the Affidavit, no further orders are necessary. It is stated in paragraph 7 of the Affidavit as follows:

*"7. I submit that the 5th respondent in the OP/petitioner in the SLP has not produced any stay order from the Apex Court till date. Therefore, I have convened the Managing Committee of SNDP Union, which is the decision making body and decided to terminate the service of the petitioner in the SLP/5th respondent in the OP and appoint the contempt petitioner. Since the classes are already over in this academic year, the contempt petitioner would be appointed w.e.f. 01.06.2008 subject to any orders passed by the Honourable Supreme Court of India in Annexure R2(a)."*

2. In the light of this development, the Contempt Petition is closed for the present. Liberty is granted to the petitioner to move this Court, if necessary.
