<u>JUDGMENT</u>

KOSHY,J.

Appellant petitioner sustained injuries in an accident due to the negligence of the driver of the vehicle insured by the 3rd respondent, Insurance company. The total amount awarded by the tribunal was Rs.1,17,000/- with 9% interest from the date of application till its deposit. The compensation awarded for loss of earning power was Rs.25,000/-. Tribunal has awarded Rs.10,000/- for permanent disability. Since the compensation was not awarded taking into account percentage of disability, as requested by the claimant, we have referred him to the Medical Board constituted by Medical College Hospital, Kottayam for assessing the percentage of disability. The Medical Board certified that permanent disability is only 3%, and being a driver, considering the difficulties in driving during night, maximum disability can be given upto 10% as

the disability noticed is only occurrence of head ache as stated by the appellant. Considering the facts and circumstances of the case and considering the percentage of disability assessed by the tribunal, we are of the view that the amount awarded by the tribunal is just and reasonable and no interference is required. Hence we dismiss the appeal.
