JUDGMENT

The petitioner is aggrieved by the refusal of the DEO who approved shifting of the petitioner as an Upper Primary School Assistant from 3-6-2008. That is a matter pending in Ext.P15 revision before the first respondent at the instance of the Manager of the corporate educational agency which is the employer of the petitioner.

Without expressing anything on merits and after hearing the learned counsel for the petitioner and the learned Government Pleader, this writ petition is ordered directing that Ext.P15 revision shall be taken up, considered and disposed of by the competent authority in accordance with law within an outer limit of three months from the date of receipt of a copy

of this judgment. An opportunity of hearing may be extended to the petitioner also, having regard to the facts and circumstances of the case.
