JUDGMENT

The petitioner is a contractor, awarded with certain works in relation to the International Container Terminal project at Vallarpadam. The allegation against the petitioner is that following certain recoveries made from the amounts to be paid to one of the sub-contractors, the amounts deducted by the petitioner as VAT was not paid to the account of the Revenue. The defence raised is that the said differential, with interest of Rs.45,000/-, was remitted.

Having considered the contents of the penalty order as also the grounds raised in the appeal, it is ordered that if the petitioner remits an amount of Rs.4,00,000/- within a period of three weeks, the penalty order Ext.P3 impugned in Ext.P4 appeal shall not be enforced pending final consideration of Ext.P4 appeal. If such payment is made, the appellate authority will
