per this instructions, the said amount of Rs.12,280/- was credited to the G.P.F. Account of the petitioner during 1999-2000 and has been included in the total deposits for the period amounting to Rs.97,600/-. The said amount of Rs.12,280/- was given retrospective credit from the month of March, 1991 and interest thereon was also granted for the period from 01.04.1991. In view of this, the writ petition is closed as infructuous. No order as to costs.
