WRIT PETITION No.11331 of 2008

ORDER: (per HON'BLE SRI JUSTICE RAMESH RANGANATHAN)

The petitioner is a public limited company engaged in the business of manufacture and sale of iron and steel. Petitioner was assessed to tax on its turnover, aggrieved by which it preferred an appeal to the Appellate Deputy Commissioner (CT), Punjagutta Division, Hyderabad, along with an application seeking stay of collection of the disputed tax. On the stay application being rejected, the petitioner preferred a revision to the third respondent, who is said to have confirmed the orders of the appellate Deputy Commissioner. The petitioner contends that the order passed by

the third respondent is still awaited. The appeal is also said to be still pending before the Appellate Deputy Commissioner.

If the respondents are permitted to recover the disputed

penalty in its entirety, the appeal pending before the Appellate

Deputy Commissioner (CT) will be rendered an empty formality.

Pending disposal of the appeal before the Appellate Dy.

Commissioner, I consider it appropriate to direct stay of collection

of the penalty disputed subject to the condition that the petitioner

deposits 25% of the penalty within a period of four weeks from

today. Amount, if any, paid already, shall be given credit to.

The writ petition is accordingly disposed of. However, in the

circumstances, without costs.
