**ORDER:** (per Sri A. Gopal Reddy, J)

This is a taken up writ petition on the basis of fax message dated 13-03-2008 sent in the name of Chandrakala to the Hon'ble the Chief Justice.

On issuing notice, the Sub-Inspector of Police, Nizamabad Rural Police Station filed an affidavit along with the statement of the husband of the petitioner alleged to have been detained by Rural Police, Nizamabad. It is stated that the alleged detenu was called to the police station for the purpose of enquiry in connection with the complaint given by one Nenavat Balaram and after enquiry he was let off. The detenu as well as the petitioner were produced before the Tahsildar-cum-Mandal Executive Magistrate, Nizamabad to record their statements. The alleged detenu as well as the petitioner stated that the police never detained the alleged detenu and the petitioner has not sent any fax message to the Hon'ble the Chief Justice and it was sent on her name by some unknown person. It is also stated that the petitioner as well as the detenu have participated in National Rural Employment Guarantee Scheme from 17-03-2008 to 19-03-2008 and that they have never detained the alleged detenu illegally as alleged in the fax message.

In view of the above averments, no adjudication is called for on the fax message. The writ petition is accordingly dismissed.
