Writ Petition No. 797 of 2008

Order:

It is the case of the petitioners that they made a representation dated 14.11.2007 requesting the 1st respondent, namely the Assistant Director of Survey and Land Records, Ranga Reddy District, to survey and demarcate their land in an extent of Ac.7.00 and Ac.6.39 gts, situated in Survey Nos. 125 and 126 of Jalpally village, Saroornagar Mandal, R.R. District, but till date no action thereon had been taken.

Learned Assistant Government Pleader for Revenue for the respondents, on instructions, submits that the matter is still under consideration before the 1st respondent.

In view of that, both the learned counsel for the petitioners as well as the learned Assistant Government Pleader for Revenue for the respondents agreed for disposal of the writ petition with the following directions:

The 1st respondent, namely the Assistant Director of Survey and Land Records, Ranga Reddy District, is directed to consider the representation dated 14.11.2007, said to have been made by the petitioners for conducting survey and demarcation of the lands in question, after issuing notices to all the necessary parties, and take necessary action in the matter in accordance with law, expeditiously, preferably within a period of eight weeks from the date of receipt of a copy of this order.

Accordingly, the writ petition is disposed of. No costs.
