Heard learned counsel for the petitioner, learned counsel for
the State and learned counsel appearing for Bihar State Electricity
Board.

Petitioner is a Ward Councilor of Ward No.22 of
Madhubani Municipality. He has preferred this writ petition by way
of Public Interest Litigation seeking intervention of this Court so that
the District Magistrate, Madhubani may pay attention to suggestions
of the municipality for widening of roads and for shifting of electric
poles to the widest point on the land available for the same and some
other suggestions.

Considering all the facts and circumstances, the writ petition
is disposed of with liberty to the Madhubani municipality to send

resolution of aforesaid matters to the District Magistrate, Madhubani without any delay so that at the time of strengthening or widening of the roads for which funds are available, the District Magistrate, Madhubani may consider the suggestions given by the Madhubani municipality and may accept those suggestions which he finds suitable for the interest of public.
