Heard learned counsel for the petitioner.

The decree holder petitioner has filed this revision application against order dated 21 11.2008 passed in Execution Case No. 7 of 1974 by which the Sub-Judge-I, Sitamarhi has entertained the application of one Buchchi Devi filed under Order 21 Rule 90 for further consideration.

The order impugned does not come within the category of case decided and it is

purely an interim order taking on record the said application for further hearing. In the circumstances, no case of interference in the matter under Section 115 of the C.P.C. is made out and the application is dismissed.

However, since the execution case appears to be of 1974 in which it appears that the auction sale was held and the same was confirmed in 1976 itself, the court below shall make all endeavours to decide the same as expeditiously as possible, preferably within a period of six months from today.
