The order dated 6<sup>th</sup> January, 2009 passed earlier shows this petition as disposed of. It, however, appears that the observation regarding disposal of the matter crept into the order through inadvertence. Accordingly, the part of the order which shows that this matter has been disposed is hereby recalled.

Heard further arguments.

The learned senior counsel appearing for the petitioners in the course of his further submission stated that the petitioners herein apprehends arrest in connection with the FIR bearing No.RC-22/2008 of the Sikkim Vigilance Police which is more or less similar in content as in Bail Appln. No.5 of 2009 - Kunwar Onkar Singh vs. State of Sikkim. It is submitted by the learned senior counsel that vide order passed today in the above-mentioned Bail Application the petitioner Kunwar Onkar Singh has been granted anticipatory bail with certain conditions. Since the facts and law applicable in the present case are similar, the learned counsel prays that the petitioners herein may also be granted anticipatory bail with similar conditions. The learned Additional Public Prosecutor raises no serious objection to such prayer made by the learned counsel for the petitioners.

Considered.

Since facts in this case are identical and the law applicable to the case is same, I find substance in the submission of the learned counsel for the petitioners and as such, I am of the view that similar order is called for.

Accordingly, this bail application is disposed of with the following order:-
