This Civil Contempt Case is filed under section-11 & 12 of Contempt of Courts Act praying to initiate contempt proceeding against the respondents-1 & 2 for willful disobedience of the order passed by the learned Single Judge in W.P.No.3944/2007 Dated. 03.01.2007.

This contempt of court case coming on for orders, this day, **Anand Byrareddy, J** made the following:

ORDER

Pursuant to the direction of this Court, it is admitted by the complainant that she is in receipt of Swatantrata Sainik Samman Pension with effect from 08.12.2008. However, it is her complaint that though she is entitled to arrears, pursuant to the original application filed by her husband on 12.10.1999 and the respondent having disputed the same, the complainant has filed the present contempt alleging violation of the order passed by this Court.

2. From the sequence of events, as this Court had directed the respondents only to consider the claim of the complainant and pass appropriate orders, it cannot be said that there is any violation of the order passed by this Court. Now the respondents having granted certain relief to the complainant, there is no ground is made

out to issue process against the respondents and therefore, the complaint stands disposed of. The remedy if any available to the complainant in respect of the alleged arrears is however left open.
