

ORDER

In the instant case, the complainant contends that the respondents are guilty of willful disobedience of the order passed by this Court on 17.4.2009 in W.P.No.81428/09 and therefore contempt proceedings to be initiated against the respondents and punish them in accordance with law.



2. Sri N.S.Deshpande, learned Government Pleader appearing for the complainant fairly submitted that the prayer sought for in the proceedings does not survive for consideration. Therefore, initiating contempt proceedings against the respondents may be dismissed as having become infructuous.

3. The submission is taken on record. The contempt proceedings is dismissed as having become infructuous at the risk of the counsel appearing for the complainant. Ordered accordingly.
