**JUDGMENT**

**Kurian Joseph, J.**

This Writ Petition is filed mainly with the following prayer:

“(ii) Issue a writ of mandamus or any other appropriate writ, direction or order directing the respondents 1 and 2 to grant adequate police protection to the smooth functioning of the cattle farm, located in 43 cents of property comprised in Sy. No. 64/8 of Edamulakkal Grama Panchayath.”

A cattle farm can be conducted only with a valid licence issued by the Grama panchayat. Therefore, this Writ Petition is disposed of directing the Grama panchayat to consider the application, if any, filed by the petitioners and take a decision on the application within one month from the date of receipt of the same. In case, the petitioners possess a valid licence for running the cattle farm, there cannot be any obstruction

from any quarters. In the unlikely event of any such obstruction in running the cattle farm, the police shall render necessary assistance and protection to the petitioners.
