Prayer in CMP(MD).No.3551 of 2006:-

These petitions are to condone the delay of 996 days in filing the applications to set aside the abatement and to bring on record the LRs of deceased $1^{\rm st}$ appellant of the second Appeal papers filed S.A.No.1589 of 1998.

- 2.I have heard the learned counsel for the petitioners and I have gone through the affidavit filed in support of the petitions. Though I am satisfied with the reasons adduced therein for condoning the delay, these petition are to be allowed with costs.
- 3.Accordingly, these petitions are allowed with a cost of Rs.1000/-(Rupees One Thousand only)payable by the petitioners to the learned counsel for the respondents within a period of four weeks form today. On such payment being made and the receipt shown to the Registry, the Registry shall post the Second Appeal for enquiry if it is otherwise in order.
- 4. It is also made clear that if any default is made in payment as stipulated above, these petitions shall stand dismissed automatically without further reference to this court.
