This writ petition is filed for the following substantive relief:

“It is prayed that this Hon’ble Court may be pleased to issue an appropriate writ or order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the 2nd respondent in seizing the stocks of 66,965.25 quintals of paddy under the cover of Panchanama dated 04-06-2008 as illegal, arbitrary and against the principles of natural justice and consequently direct the 1st and 2nd respondents to release the stocks.”

The learned counsel for the petitioners circulated letter dated 30-07-2009 to the Registry, wherein he stated that he was instructed by the petitioners to withdraw the writ petition.

In view of the same, the writ petition is dismissed as withdrawn.

As a sequel to dismissal of main petition as withdrawn, WPMP No.15634 of 2009 filed by the petitioners for interim relief is disposed of as infructuous.
