Heard counsel for the petitioner and counsel appearing for the State.

Petitioner's case is case on the basis of mapping register prepared unauthorisedly by the Mukhiya of the Gram Panchayat, without any direction from the competent authority, the candidature of petitioner has not been considered for the post of Anganwari Sevika and JankiDevi, earlier working as Anganwari Sahaika, has illegally been selected for the post.

In case of non-consideration of petitioner's candidature for selection, she should have filed affidavited objection before the District Magistrate, for which there is

specific provision under clause 8 of the guidelines for selection of Anganwari Sevika.

This application is being disposed of, giving liberty to the petitioner for filing her objection before the District Magistrate within two weeks from today. In case such an objection is filed by the petitioner, the District Magistrate will dispose it of as per the guidelines in accordance with law, within the specified time i.e. one month from the date of it's filing.
