Heard learned counsel for the petitioner and the learned counsel appearing for the respondent-University as also the State.

The grievance of the petitioner is that although he has been paid his retiral dues, but pension has not been correctly fixed.

Learned counsel appearing for the respondent-University submits that the averments made in the writ application as well as Annexures are not clear to enable consideration of the case of the petitioner.

In the above circumstances, learned counsel for the petitioner submits that for expeditious disposal of the pending claims

as highlighted in this writ application, the petitioner proposes to file a representation before the Registrar, Tilka Manjhi Bhagalpur University, Bhagalpur (respondent no.6). In case such a representation is filed stating the details of the unpaid claims as also enclosing the copy of the relevant documents, if any, in support of such claims along with the certified copy of the present order within a period of six weeks, the grievances of the petitioner as raised in his representation be considered in accordance with law expeditiously, preferably within a period of four months on receipt of such representation. Upon consideration, if any amount is found payable, the same may also be paid with interest permissible under the rules.

The writ application stands disposed of with the above
