**ORDER (ORAL)**

(Passed on 30<sup>th</sup> day of September, 2010)

1. Learned counsel appearing for the petitioner submits that the order impugned dated 14.09.2010 (Annexure P-1) was passed, directing recovery of Rs. 80,04,084/-. Against that, the petitioner has already preferred an application/letter dated 23.09.2010 (Annexure P-4) for clarification regarding scheduling of energy by Biomass plants as per order dated 15.01.2008, to the Chhattisgarh State Electricity Regulatory Commission (for short "CSERC"). The same is pending consideration. Today, being the last day, if no interim order is granted, the Chhattisgarh State Power Distribution Co. Ltd. (for short "CSPDCL") may proceed with the recovery of the amount.
2. Be that as it may, it appears that pursuant to the order dated 15.01.2008, passed by the CSERC, the impugned order was passed. The petitioner has immediately preferred an application / letter to the CSERC for clarification of the order.
3. In view of that, it would not be proper to entertain the petition at this stage when the application/letter is already pending before the CSERC for consideration/modification of the earlier order. However, having regard to the total facts, it is expected that the application/letter dated 23.9.2010 filed by the petitioner would be considered and decided by the CSERC as expeditiously as possible, preferably within a period of 4 weeks.
4. Accordingly, the writ petition is disposed of. No order as to costs.
