

### AWARD

(Passed on 30-10-2010)

Parties file a compromise petition. The terms are just. We hereby record the compromise and pass an award in terms of compromise, and order that respondent No. 3 shall pay to appellants a sum of Rs 30,000/- (Rs. Thirty Thousand only.) by way of compensation, in addition to the amount already paid/awarded by the Claims Tribunal within a period of 2 months from today, failing which, this amount shall carry interest @ 6% per annum for the period commencing from the date of completion of 2 months till its realization. The order of apportionment, if any, shall be followed.
