

- 2. Disposal of Writ Appeal No.89/2009 shall also govern the disposal of Writ Appeal No.90/2009, as they arise out of a common order dated 5-3-2009 passed by the learned Single Judge in Writ Petitions (L) No.2760/2008 and 2761/2008. By the impugned order dated 5-3-2009, both the writ petitions preferred by the State of Chhattisgarh through Divisional Forest Officer, Bhanupratappur, West Kanker (Chhattisgarh) have been allowed and the order dated 7-12-2007 passed by the Labour Court, Rajnandgaon has been quashed.
- Brief facts of the case are that the appellants Puna Ram Yadav 3. and Arvind Sonkar were appointed as daily wager though the appellants had raised a plea before the Labour Court that they were appointed under the Divisional Forest Officer but the xerox copies of the documents annexed with the writ petitions show that they were appointed on daily wage basis by the Managing Director of the Zila Vanopaj Sahkari Sangh Maryadit, Bhanupratappur, West Kanker and their services were dispensed with vide order dated 7-3-2000, a xerox copy of which is annexed as Annexure R-2/1 with the return of the said Managing Director/respondent No.2 in both the writ petitions. Further, the Managing Director/respondent No.2 has also filed xerox copy of a document with Writ Petition (L) No 2760/2008, which is the certificate and voucher of muster roll No.6202/36, showing payment of wages of Rs.6,351/- by the Managing Director for the period from 1-4-1994 to 30-4-1994 and has also filed xerox copy of another document with Writ Petition (L) No.2761/2008 as Annexure R-2/3, which is the certificate and voucher of muster roll No.6202/08, showing payment of wages of Rs.5,242/- by the Managing Director for the period from 1-3-1994 to 30-3-1994. 4. After perusing the documents, we are of the firm view that the finding of the Labour Court is totally perverse and contrary to the documentary evidence.
