Shri S.P.Kale, counsel for the petitioner. Shri Smita Ghai, P.L. for the State.

Grievance of the petitioner in the present petition is that though he is entitled for his regularization on the post of Forest Guard, he has been regularized on the post of watchman.

Shri Kale submits that the petitioner has not filed any such regularization order on the post of Watchman but the fact remains that the regularization order has already been passed.

Counsel for the petitioner submits that the respondents have completed all the formalities for passing necessary order in favour of the petitioner and therefore at this stage the petitioner may be permitted to withdraw the present petition with liberty to file a fresh representation before respondent No.2 and the same may be directed to be decided in accordance with law as expeditiously as possible.

Counsel for the State submits that without ascertaining the fact he cannot make any statement whether the State Government is willing to regularize the services of the petitioner on the post of Forest Guard or not. However, he has no objection if the petitioner makes a representation before the authority concerned and the same is decided by it in accordance with law.
