AWARD

We hereby record the compromise and pass an award in terms of compromise, and order that respondent No. 3 shall pay to appellant a sum of Rs 1,40,000 (One Lakh Forty Thousand) by way of compensation, in addition to the amount already paid/awarded by the Claims Tribunal within a period of 2 months from today, failing which, this amount shall carry interest @ 6% per annum for the period commencing from the date of completion of 2 months till its realization. The order of apportionment, if any, shall be followed.
