2. The Petitioner in all the writ petitions is seeking a direction from this Court directing the Respondents to permit the Petitioner to run its establishment till 5 a.m. on 1st January, 2011 and permitting the establishment to organize an orchestra performance till 5 a.m. in the morning. Reliance is placed on number of orders passed by the Division Bench of his Court.
