THIS M.F.A. COMING ON FOR CONCILIATION BEFORE THE LOK ADALAT THIS DAY, THE FOLLOWING ORDER IS PASSED:

## **CONCILATION ORDER**

This M.F.A. is filed u/s. 173 (1) of M. V. ACT against the judgment and award dated:17-03-2007 passed in MVC NO:31/2002 on the file of the Motor Accidents Claims Tribunal, Ranebennur.

The learned Counsel for the Appellant and the representative of the Respondent and the learned Counsel for the Respondent are present.

After negotiations, the matter is settled. The Insurance Company has agreed to pay and Appellant has agreed to receive a lump sum compensation of Rs.80,000/-.(Rs. Eighty thousand only) inclusive of interest, in addition to what has been awarded by the Tribunal, in full and final settlement of the claim. We are satisfied with the compensation, which is in the interest of the minor.

The Insurance Company shall deposit the said amount before the Tribunal within six weeks from the date of preparation of Award, failing which the said amount shall carry interest @ 9% p.a. from the date of default, till the date of deposit.

We are satisfied that the settlement arrived between the parties is just and proper.

IN

From out of the enhanced compensation amount, 60,000/- shall be kept in a term deposit initially for a period of five years in any Nationalised Bank. The appellant is permitted to withdraw interest thereon. Balance of Rs.20,000/- shall be released in favour of the Appellant.

This Misc. First Appeal stands disposed of in terms of Joint Memo Award of the Tribunal is modified. Draw the award accordingly.
