

The Miscellaneous First Appeal filed against the Judgment and Award passed by the above Tribunal having been referred to Lok Adalat on 15/04/2010 coming on for settlement before Lok Adalat on 27/09/2010 in presence of the Officers of the United Inida Insurance Com., Ltd., and the Advocates appearing for respective parties, for the reasons stated in the conciliation order:

It is Ordered and decreed that the 2<sup>nd</sup> Respondent- the United Inida Insurance Co. Ltd., shall pay and the Appellants shall receive a LUMP SUM Compensation of Rs.22,500/- (Rs. Twenty Two thousand and Five Hundred only), inclusive of interest in addition to what has been awarded by the Tribunal, in full and final settlement of the claim.

2. And it is further Ordered and Decreed that the 2<sup>nd</sup> Respondent-the United India Insurance Co. Ltd., shall deposit the said amount before the Tribunal within Six weeks from the date of preparation of award, failing which the said amount shall carry interest at the rate of 9% p.a. from the date of default, till the date of deposit.

3. And it is Further Ordered and Decreed that there shall be no order as to the costs. Joint memo is enclosed to this Award.


