JUDGMENT

It is submitted by the learned Government Pleader that the Apex Court in S.L.P.(Civil) Nos.6896-6898/2010 and connected cases has passed the following order:-

"......We have perused the document dated August 20, 2010 handed over in Court by Mr.Jaideep Gupta, learned Senior Counsel for the appellants, which indicates that with effect from August 20, 2010, teachers such as the respondents before us will be entitled to receive salary from the State Government.

We, accordingly, feel that at this stage no further orders are necessary. The appellants shall pay the salary to the teachers as per the aforesaid order dated August 20, 2010 regularly. This will be, of course, subject to the claim of the respondents with regard to the arrears."
