ORDER

Barkath Ali, J.

Heard the counsel for the claimants and the counsel for the Insurance Company. Insurance Company has no objection in allowing the review petition . Hence the review petition is allowed as found below ;

2. Instead of multiplier 15, multiplier of 17 is adopted and towards loss of dependency, claimants are found entitled to a compensation of Rs. 3,40,000/-. Towards loss of consortium, claimants are found entitled to an additional compensation of Rs. 8,000/- and towards medical expenses, they are found entitled to a compensation of Rs. 1500/-.

3. Thus the claimants are found entitled to an additional compensation of Rs. 1,09,500/-. Instead of 9% interest awarded, they are entitled to interest @ 7.5% per annum.

The judgment and award of this court dated March 22, 2010 is modified as found above.
