JUDGMENT

The petitioners in this writ petition are students of the B.Tech (Electrical and Electronics) Engineering Degree course, who have applied for revaluation to the University of their answer papers. They complain that the delay in carrying out the revaluation is causing undue hardship and loss to them. Therefore, they pray for the issue of appropriate directions for the conduct of the revaluation expeditiously.

2. Adv.T.A.Shaji, who appears for the Mahatma Gandhi University submits that the applications for revaluation have been submitted only in April, 2010. At least two months' time is required to complete the revaluation process.

3. In the above circumstances, this writ petition is disposed of directing the Mahatma Gandhi University to complete the revaluation of the answer papers of the petitioners, as expeditiously as possible and at any rate,

within a period of two months from the date of receipt of a copy of this judgment. It is clarified that the above direction is subject to the condition that the applications for revaluation submitted by the petitioners are in order and free from any defects.
