**J U D G M E N T**

The petitioner has applied for admission to the G.V. Raja Sports School, Thiruvananthapuram. Petitioner has been included as rank No.3, in the supplementary list. The first stage of admission is already over. According to the petitioner, 15 more vacancies are there. Therefore from the supplementary list, 15 candidates have to be admitted. Being rank No.3, the petitioner is entitled to get admission to one of the vacant seats is the petitioner's grievance. It is under the above circumstances the petitioner has filed this writ petition seeking the following reliefs:

- i) to issue a Writ of Mandamus or order direction to the 2<sup>nd</sup> respondent to admit the Petitioner in Standard VIII for the academic years 2010 – 2011 based on his rank in the Reserve List published by the first respondent.
- ii) To issue a Writ of Mandamus or order or direction to the 2<sup>nd</sup> respondent to consider and pass appropriate orders on Ext.P3 representation as expeditiously as possible and at any rate within a time limit that may be fixed by this Hon'ble Court.

2. The learned Government Pleader on instructions submits that the petitioner would be given admission and memo has already been despatched to him. This is recorded and the writ petition is closed.
