J U D G M E N T

The petitioner is included in Ext.P1 ranked list published by the 3<sup>rd</sup> respondent for appointment to the post of Draftsman Grade-III/Overseer (Civil) in PWD/Irrigation Department. According to the petitioner, despite the existence of vacancies, vacancies are not reported. It is with this grievance this writ petition has been filed.

2. Learned Government Pleader has obtained instructions in the matter. According to the learned Government Pleader, 76 vacancies have been reported by the 1<sup>st</sup> respondent in the following manner:-
