J U D G M E N T

Petitioner claims to be a PWD `A' class Contractor. Ext.P1 is a tender notice published by the respondents and in so far as this writ petition is concerned, the work mentioned in Ext.P1 is the improvement to Pazhassi Dam Garden Road. According to the petitioner, on conclusion of the tender process, the tender is going to be awarded to an ineligible person and that the same is against Ext.P3 Government Order.

First of all, on the petitioner's own admission, he did not even submit his tender in response to Ext.P1. Therefore Petitioner is not an aggrieved person. Secondly, the Government Order, on the basis the petitioner contends that since there were only three tenderers work should have been retendered, applies only to the tenders invited by the Irrigation Department. No material has been produced to show that the Government Oder is applicable to the Public Works Department.

I am not persuaded to entertain the writ petition. Writ petition fails and is dismissed.
