JUDGMENT

The complaint of the petitioner is that her application for correction of the name of her son from "Danu Sabu" to "Sanu Sabu" has not been considered or disposed of so far. According to the petitioner, correction of the Birth Certificate of the child is required for filling up his personal details in his S.S.L.C book. He is now studying in the Std.X. As per interim order dated 13.12.2010, this court had directed the petitioner to obtain a consent letter from the father of the child, who is presently employed abroad, attested by an officer of the Indian Consulate in the country where he is employed. It is submitted by the petitioner that the certificate, as required by the interim order has also been produced by her. A copy of the affidavit of the father has been produced in these proceedings, marked Ext.P8. Therefore, according to the petitioner, there is no other impediment in granting the request in Ext.P6. In view of the above, she seeks appropriate directions for an expeditious

disposal of Ext.P6.

2. Mr.Subash Chand, Advocate, who appears for the respondents assures me that the request in Ext.P6 would be considered and appropriate orders would be passed without further delay.

3. In the above circumstances, this writ petition is disposed of directing the 2^{nd} respondent to consider the request of the petitioner, evidenced herein by Ext.P6, in accordance with law and to pass appropriate orders thereon, as expeditiously as possible and at any rate, within one week of receipt of a copy of this judgement. The petitioner shall produce a copy of this judgement before the 2^{nd} respondent for prompt compliance.
